#### ★ Strategic Plan Overview

The Montana Logging Association's five-year strategic plan outlines four key goals guiding our staff and board of directors.

#### **1** Deliver High-Value Services to MLA Members

The MLA continues to provide industry-specific services that promote professional development, safety, and insurance access.

- Three regional representative conducted on-site safety visits for participants in Montana State Fund Trade Group and Associated Loggers Exchange programs travelling over 73,690 miles to support member safety and outreach.
- Jason participated in monthly OSHA conference calls as part of our industry alliance, focusing on health and safety priorities and areas of special emphasis. That information is then directly conveyed to MLA Members that could be impacted.
- Regional representatives hosted 26 in-person First Aid/CPR & Wildland Fire workshops using updated training videos and interactive CPR manikins. Workshops are held in regions around the state to be accessible to MLA members.
   Each year our training program is updated with new content.
- Justin and Tim met with Idaho Safety consultants in Coeur d'Alene to keep a good working relationship with other logging Safety Consultants discussing industry trends in accidents and claims.
- Jason, Justin and Tim participated in the Montana State Fund Safety Forum in Helena meeting with safety consultants from other industries.
- Justin facilitated the Forest Stewardship Workshop for Loggers in Kalispell and offered 8 different workshops for continuing education. The Accredited Logging Professional Program continues to set the standard for logger training in the US offering business workshops.
- MLA Services represents nearly 200 work comp policies for our members between the Associated Loggers Exchange and Montana State Fund. MSI offers competitive workers' compensation insurance programs to MLA members.
- Provide health insurance options—including individual, group, Medicare, and ancillary products—through BlueCross BlueShield of MT, Mountain Health Co-op, and Pacific Source.

#### 2 Advocate for Montana Timber Harvesters

We serve as a visible and effective voice in policy and legislative matters.

- During the 2025 Legislative Session, MLA lobbyist, Jason Todhunter actively worked on 24 bills and monitored over 50 additional bills related to natural resources, transportation, taxation, and work comp.
- Jason Todhunter engaged MLA members to participate in legislative committee meetings and provide valuable input.

- Helped to coordinate the 2024 Montana State Capitol Christmas Tree
- Interviewed by several news media including the KTVQ News, the Flathead Beacon, Daily Interlake, Hungry Horse News and Kootenai Valley Record on relevant industry issues.

- Provided a presentation to the HICHAS Research days safety forum on how the MLA has utilized grant funding the past few years to improve safety programs that the MLA provides.
